

**MINUTES OF THE PUBLIC HEARING OF THE COUNCIL OF THE CITY OF
WATERVLIET, WEDNESDAY, MAY30, 2012 AT 7:00 P.M.**

The Public Hearing was called to order by Mayor Michael P. Manning at 7:00 P.M.
