CITY OF WATERVLIELT BULK ITEM PICK UP

The City of Watervliet designates bulk item disposal dates once a month. If you would like to schedule a pick-up, come to the City Clerk's office for the paperwork. There is a fee of \$25 that must be paid in order to schedule the pick-up (cash or check only). Bulk items must fit into a 4 foot high by 4 foot wide by 8 foot long area. **Bulk amounts larger than this will not be picked up. All smaller objects must be placed in containers.** Please see the list below for items that the City of Watervliet cannot pick up. SOLID WASTE SHALL NOT CONTAIN THE FOLLOWING:

1. EXPLOSIVES OR AMMUNITIONS
2. COMBUSTIBLE LIQUID OR GAS CONTAINERS, BOTTLES, CYLINDER, CANS OR PROPANE TANKS
3. NO REFRIGERATORS OR AIR CONDITIONERS
4. NO BATTERIES
5. NO TIRES
6. NO CONSTRUCTION DEBRIS
7. NO TELEVISIONS OR ELECTRONICS
8. CAUSTIC ACIDS, CORROSIVES, CHEMICALS OR OTHER HAZARDOUS WASTES, RADIOACTIVE OR OTHER CONTAMINATION OR POLLUTANTS PROHIBITED BY MANDATORY AND BINDING LAWS OR REGULATIONS OF THE UNITED STATES AND NEW YORK STATE
9. LIQUID OR SLURRY WASTES, UNUSED PAINT OR USED PAINT CANS
10. UNOPENED CONTAINERS, EXCEPT EMPTY HOUSEHOLD SPRAY CANS
11. NO LAWN CLEARING DEBRIS INCLUDING GRASS, LEAVES, STUMPS, TREE TRUNKS OR LIMBS
12. THICK WALLED OR SOLID METALLIC OBJECTS SUCH AS CASTINGS, FORGINGS, GAS CYLINDERS OR MOTORS
13. STEEL OR NYLON ROPE, CABLES, OR SLINGS MORE THAN FOUR FEET LONG
14. CASE HARDENED OR ALLOY STEEL CHAINS OVER 3/8 INCHES IN DIAMETER OR 4 FEET IN LENGTH
15. ANIMAL WASTES OR PARTS OF ANIMALS OTHER THAN NORMAL HOUSEHOLD GARBAGE
16. NO RECYCLABLES AS DETERMINED BY THE COMMISSIONER OF THE DEPARTMENT OF GENERAL SERVICES
17. SOLID BLOCKS OF METAL, RUBBER OR PLASTIC IN EXCESS OF TWO CUBIC FEET
18. ANY MATERIAL CLASSIFIED AS INFECTIOUS, HAZARDOUS WASTES (CONTAMINATED HYPODERMIC NEEDLES, SYRINGES, BROKEN GLASS AND SCALPEL BLADES, ISOLATION WASTE, CULTURES AND STOCK FROM LABORATORIES, HUMAN BLOOD AND BLOOD PRODUCTS)
19. NO BARRELS OR DRUMS
20. NO ASBESTOS WASTE
21. NO INCINERATED OR PARTIALLY INCINERATED MATERIALS
22. INDUSTRIAL WASTES, WASTES THAT ARE NOT EASILY RECOGNIZABLE OR WASTES THAT MAY POSE A HEALTH RISK TO LANDFILL EMPLOYEES WILL ONLY BE ACCEPTED WITH WRITTEN APPROVAL FROM THE LANDFILL
