Saqib Choudry was present on behalf of the application. He is seeking to subdivide an 88×100 foot lot into two lots; and the square footage of both lots meets the minimum requirements.

Sandy Borowsky, residing at 1427 5th Avenue, Watervliet, New York, brought up an underground stream that she believed ran along the side of the property and down the alley. She wanted to know if a prospective house on that property would affect this stream. Mr. Gilchrist was unaware of such a stream and said he would look into it. Chairman Whitehead made it clear the applicant was looking for permission to subdivide the land only.

Chairman Whitehead went over SEQR and it was decided this was an unlisted Type 2 action with no significant adverse impact to the environment and that the Watervliet Planning Board was the lead agency. A motion was made by Mr. Duffey and seconded by Mr. Sylvester.
