City Manager Joe LaCivita spoke to the council on the following issues:

- City work truck replacement through the CHIPS program
- Updated the Council on the award of a sidewalk bid to Dan's Hauling for the demolition 703 7<sup>th</sup> Street.
- Phase 2 of the Lead Line grant program will be available to residents on September 15th. Applications will be received by the city from October 1<sup>st</sup> thru December 31<sup>st</sup>.
- The city will put out an RFP for security fencing project at the filtration plant on September 10<sup>th</sup> with proposals due by September 30<sup>th</sup>. This is part of a WIIA grant.
- An RFP will be released soon as the city is looking at options as to where to dump recyclables.
