MINUTES OF THE MEETING OF THE COUNCIL OF THE CITY OF WATERVLIET THURSDAY, SEPTEMBER 1ST, 6:00 P.M.

The meeting was called to order by Mayor Patricelli 6:03 P.M.

Roll call showed that Mayor Patricelli, Councilwoman Diamond, and Councilman Daus were present.

Also present from City Administration were General Manager Joe LaCivita, Brian Kremer of Goldberger & Kremer, and Director of Finance Amanda Austin

Mayor Patricelli led the Pledge of Allegiance.

Councilwoman Diamond made a motion to dispense with the reading of the minutes from the 8-04-2022 Council Meeting which was seconded by Councilman Daus. A vote was taken to approve the meeting minutes which passed 3-0.

REPORT OF OFFICERS AND COMMITTEES

General Manager Joe LaCivita updated the council on the following items:

- Introduced Steve Golding to the council. Mr. Golding will start work for the city on September 6th.
- The city was awarded \$5.5 million as part of the CDTC's Transportation Improvement Program. The funding will be used in the redesign and reconstruction of the 25th Street corridor from Broadway to Crab Apple Lane.
- Applications were released for the CDBG Housing Rehabilitation grant program recently. The city sent out 75 applications to residents who expressed interest in the grants and todate (5) completed applications have been received.
- The city took possession of two dump truck vehicles for the Highway department and one work truck for the Water department this past week.
- The (2) vehicles purchased in October 2021 for the police department have been received and are in service.
- City pool closed on Friday, August 19th. There were over 2,300 pool passes sold for this year.
- The crew team from Emma Willard will be using the boat house at Hudson Shores Park beginning in September.
- City received (1) bid for the proposed boat services at Hudson Shores Park. It is anticipated that these services will begin in the Spring of 2023.

- The bids for the RFP that was released for the construction of a new dock in Hudson Shores Park came in higher than anticipated. The city is working with Luizzi Brothers to purchase dock materials.
- The RFI for a proposed restaurant in Hudson Shores Park is due tomorrow.
- Striping on 19th Street and 12th Avenue will begin next week.
- It is anticipated that the water service will be terminated next week to 1000 25th Street which will complete the demolition project at this property.
- It is anticipated that the window installation project at City Hall will begin on 9/15/22.
- Updated the council on the 8th Street and 8th Avenue paving and curbing projects.
- Updated the council on the Lead Lateral Replacement program.
